Ajiri ro 6 aer allōñ im emōj aer wā mokta lak - 4 yiiō dettan rej rōjañ in bök 1 ako 2 wā in 2023-2024 Moderna ako Pfizer COVID-19 wā (ien im jote nōmba in wā ñan kōmmane ej pedped ion COVID-19 wā[ko] emōj aer bök).

Ajiri ro 5 yiiō im ruttolak im ej jimwe ñan ien kin COVID-19 wā ñe rej bök joñan eo 1 wā in 2023-2024 Moderna ako Pfizer COVID-19 wā emōj an kakaal.
