Horudhaca dhamaystirka shahaadada Certificate of Immunization Status (CIS, Shahaadada Aqoonsiga Tallaalka): Soo daabaco foomka Immunization Information System (IIS) ama gacantaada ku buuxi foomka.

Si aad u daabacato foomka xogta tallaalka ee gacanta lagu buuxshay:

Waydii haddii xafiiska dhakhtarkaagu uu xogta tallaalka kudaro WA Immunization Information System. Hadday sidaas yeelaan, ka codso inay soo daabacaan CIS ka ku jira IIS kadibna xogta tallaalka cunugaaga ayaa si ootomaatig ah loo buuxinayaa. Waxaad sidoo kale daabacan kartaa CIS markaad guriga joogto adoo iska qoraaya kadibna galaaya MyIR oo ka galayso <https://wa.myir.net>. Si aad foomka ugu buuxiso gacantaada:

1. Ku qor magaca cunugaaga iyo taariikhdiisa dhalashada, kadibna magacaaga ku saxiix meesha loogu talagalay ee bogga koobaad.
2. Qor taariikhda kuurada tallaalka kasta ee cunugu qaatay adoo ku qoraaya godadka taariikhda (adoo u qoraaya qaabka Bisha/Maalinta/Sanadka). Haddii cunugaagu qaato tallaalka iskudar ah (hal cirbad tallaalka oo ka hortagaysa xanuun kaladuwan), adeegso tasmada Tixraaca Hoose si aad talaal kasta ugu qorto si sax ah. Tusaale ahaan, ku qor Tallaalka Pediarix hoosta tallaalkada Diphtheria, Tetanus, Pertussis as DTaP, Hepatitis B u qor sida Hep B, halka Polio aad ku qorayso IPV.
3. Haddii cunugaagu qabo xanuunka busbuska (varicella) uusana marin tallaalka xanuunka, dhakhtarka caafimaadku waa inuu xaqiijiyaa xanuunka busbuska si loo buuxsho shuruudaha dugsiga.
 - Haddii dhakhtarkaaga daryeelka caafimaadku xaqiijin karo in cunugaagu uu qaaday xanuunka busbuska, waydii dhakhtarkaaga inuu tig saaro bokiska ku qoran qaybta Documentation of Disease Immunity (Dukumiintiga Xanuunada Difaaca) irka kadibna uu saxiixo foomka.
 - Haddii shaqaalaha dugsiga galo IIS ayna arkaan cadaaynta i cunugaagu soo maray xanuunka busbuska, ayaga ayaa tig saari doona bokiska qaybta xanuunka Varicella ee qaybta tallaalkada.
4. Haddii cunugaagu uu muujiyo in difaaca jirkiisu bad qabo marka baaritaan dhiiga ah lagu sameeyo (titer), u sheeg dhakhtarkaaga inuu tig saaro bokisyada xanuunka ku haboon ee ku qoran qaybta Documentation of Disease Immunity, kadibna saxiixaan oo taariikhda ku qoraan foomka. Waxaa qasab ah inaad keento warbixinada shaybaarka ee ku jira CIS kaan.
5. Keen cadaaynta diiwaannada caafimaad ahaan la xaqiijiyay, adoo raacaaya tilmaamaha hoose.

Diiwaannada Caafimaadka ee la Aqbali karo

Dhammaan Diiwaannada tallaalka waa inay noqdaan kuwo caafimaad ahaan la hubiyay. Tusaalaha waxaa kamid ah:

- Foomka Certificate of Immunization Status (CIS) oo la daabacay ayna ku cad yihiin taariikhaha tallaalka ee Washington State Immunization Information System (IIS), MyIR, ama nidaamyada kale ee IIS yada gobalka.
- Koobiga waraaqda ah ee la buuxshay ee CIS oo uu ku cad yahay saxiixa xaqiijinta ee dhakhtarku.
- Koobiga waraaqda ah ee la buuxshay ee CIS oo ay la socdaan diiwaannada tallaalka ee lagasoo daabacay diiwaanka kumbuyuutarka ee dhakhtarka caafimaadka oo uu ku qoran yahay saxiixa ama tiimbarada dhakhtarku. Maamulaha dugsiga kalkaalisada, ama wakiilkiisu waa inuu xaqiijiyaa taariikhaha ku qoran CIS inay yihiin kuwo si sax ah loo qoray uuna saxiixaa foomka.

Xaalada Shardiga ah

Carruurta waxay gali karaan ayna sii dhigan karaan dugsiga ama xarun daryeelka carruurta bixisa oo leh shardi lagusoo galo haddii ay carruurta helayaan tallaalka loogu baahan yahay galitaanka dugsiga ama daryeelka ilmaha. (Kuurooyinka taxanayaasha tallaalka waxaa lagu baxshaa mudada u dhaxaysa ee ugu yar, marka carruurta qaarkood ayaa laga yaabaa inay sugaan muddo ka hor intaysan dhamaysan tallaalkada. Tani waxay ka dhigan tahay inay gali karaan dugsiga intay sugayaan talaalkooda xiga ee qasabka ah). Si uu u galo dugsiga ama daryeelka carruurta oo aqoonsi shardi ah leh, waxaa qasab ilmaha ku ah inuu qaato dhammaan kuurooyinka tallaalka uu xaqa u leeyahay ka hor intuu bilaabin dugsiga ama xarunta daryeelka carruurta.

Ardayda ku jira xaalada shardiga ah waxay sii dhigan karaa dugsiga intay sugayaan taariikhda ugu yar ee uu ku dhacaayo tallaalka inta laga gaaraayo kuurada xigta ee tallaalka oo ay la socdaan 30 maalmood oo ah mudada ay ku keenayaan cadaaynta talaalka. Haddii ardaygu uu maraayo tallaalo badan, xaalada shardiga ah way sii soconaysaa qaab kii hore la mid ah ilaa dhammaan tallaalkada loo baahan yahay ay dhamaystiran yihiin.

Haddii mudada 30 maalmood ee shardiga ah ay dhamaato aana la keenin dukumiintiyada dugsiga ama xarunta daryeelka, markaas waxaa qasab ah in ardayga laga saaro inuusan dugsiga sii dhigan, sida ku cad RCW 28A.210.120. Dukumiintiyada saxda ah waxaa ku jira cadaaynta difaaca ka dhanka ah xanuunka muranku ka jiro, diiwaannada caafimaad ee muujinaaya tallaalka, ama Certificate of exemption (COE, foomka shahaadada reebista tallaalka) oo la buuxshay.
