- 5) If 40-hour HAZWOPER was taken over one year ago, **also** submit a copy of your **current** 8-hour annual HAZWOPER refresher certificate.
- 6) Copy of the CDL Worker Course completion certificate, with class date and exam score.
- 7) Copy of a valid state-issued driver's license.

For Renewal certification submit:

- 1) Completed application form.
- 2) Application fee.
- 3) Two official passport photos.
- 4) Copy of 40-hour HAZWOPER certificate.
- 5) If 40-hour HAZWOPER was taken over one year ago, **also** submit a copy of your **current** 8-hour annual HAZWOPER refresher certificate.
- 6) Copy of the DOH CDL Worker Certificate.
- 7) Copy of the CDL Refresher Course completion certificate obtained in the previous two years.
- 8) Copy of a valid state-issued driver's license.
