RE: Conversion of State Registered Domestic Partnerships to Marriages

On June 30, 2014, your state-registered domestic partnership will convert to a marriage unless one or both of you are age 62 or older or you marry by June 30, 2014. If your domestic partnership converts to a marriage, you will be able to obtain a Washington State Marriage Certificate starting in July. We are writing to inform you of an opportunity to provide us with additional information to make your marriage certificate as complete as possible.

Enclosed is a sample of what a marriage certificate will look like without any additional information from you. Your marriage certificate will only contain information we receive from the Secretary of State's office from your domestic partnership registration (e.g., your name and date of birth), your date of marriage (June 30, 2014), and your legal date of marriage, which is the date of your state-registered domestic partnership (RCW 26.60.100).

If you want to have a more complete marriage certificate, please fill out the enclosed form and return it in the enclosed postage paid envelope by **April 15, 2014**. You will need to submit information for both spouses on the same form and add your domestic partnership registration number. The form also includes a place to provide your social security numbers. We need your social security number because state law (RCW 70.58.055) requires us to collect this information for all couples married in Washington. Social security numbers are not shown on marriage certificates.

After June 30, 2014, you may request a copy of your Washington State Marriage Certificate. Information on ordering a certificate is available on our website at [www.doh.wa.gov](http://www.doh.wa.gov) under the "How Do I?" heading. The cost for a certificate is \$20. We will process requests in the order received. We encourage you to order by phone, web or mail since we have limited capacity for walk-in customers.

If you married in Washington State after December 6, 2012 and before June 30, 2014, you can have the legal date of marriage (i.e., date of domestic partnership) added to your marriage certificate. The form to add legal date of marriage is on our website.
