

**Warren Featherstone Reid Award
Nomination Form 2009**



A graduate of the University of Washington, Reid served under Senator Warren G. Magnuson for almost 20 years, advising Congress on initiatives such as Medicare and Medicaid and working to expand federal support for research. He also helped establish the Nurse Training Act, the National Health Service Corps, and the National Health Manpower Act. As a later advisor to Governor Booth Gardner, Reid helped to pass the Basic Health Plan and the Washington Health Service Act of 1993. Warren Featherstone ("Feather") Reid passed away on October 20, 2002.
