In accordance with WAC 246-310-080, Proliance Surgeons, Inc., P.S. ("Proliance Surgeons") hereby submits this Letter of Intent proposing to operate Lakewood Surgery Center as a certificate of need approved ambulatory surgery center ("ASC") in the West Pierce County secondary health services planning area. Lakewood Surgery currently operates as a certificate of need approved ASC with two operating rooms. Lakewood Surgery Center proposes to add two operating rooms to its facility, resulting in a total of four operating rooms at its facility.
