Rulemaking

The Department of Health's Office of Community Health Systems officially filed a CR-101 with the Office of the Code Reviser on **August 15, 2023** to open WAC 246-976 Emergency Medical Services and Trauma Care. **The WSR number is 23-17-070.**

The organ transport service and vehicle rules establish qualifications and standards for the issuance, suspension, and revocation of an organ transport service license and organ transport vehicle license.

The Department of Health (department) is conducting rulemaking in response to new legislative requirements under Substitute House Bill (SHB) 1271 (chapter 290, Laws of 2023) regarding organ transport vehicles. The department is considering creating new sections in chapter 246-976 WAC.
