

Make Referrals p. 1 - 6	 Policy Added to 3, a: Social and Health Services all participants. Refer participants to public assistance and health related programs using one of the following options: Revised 3, a, 1st bullet: Removed "all participants" and added "social services." Added 3, a, 2nd bullet: Local Referral List: list of current local health-related and public assistance programs in the area. Added 3, d: Lead testing – referral all children who haven't received a blood lead test to the health care provider for testing. Added, 3, d, bullet: Sharing the WIC ID and Card Folder with the Help Me Grow WA and the Washington State Recovery Help Line assures all participants and caregivers have drug and other harmful substance abuse counseling and treatment resources available. Revised 4, added italicized word: Document <i>all</i> referrals in the participant's file on the Referral Program screen. 	Staff are no longer required to refer to the Help Me Grow WA Network, they can provide a list of local resources instead.
	 Procedure Revised B, added italicized words: Refer all participants and applicants, including those who aren't eligible for WIC, to social and health services by providing a local referral list or the Help Me Grow WA Network phone number 1-800-322- 2588 or website <u>https://helpmegrowwa.org/</u> address. Added to D, 1: Staff with access can use the Washington State Immunization Information System (WSIIS) in lieu of a hard copy immunization record. Removed D, Notes: Removed details about screening for immunization status. Refer to the Immunization policy. Added E: Ask parents and caretakers of children about lead testing at each initial

p. 7	 Revised Procedure A: Added: Document referrals to social services, public assistance, and health related programs. Removed: Document the Help Me Grow WA Network referral for all participants. 	
Screen Immunization Records p. 8 - 11	 Policy Added 2nd bullet to #2: Staff can use the Washington State Immunization Information System (WSIIS) to screen a participant's immunization status if they have access. Added Note to # 2: WIC staff don't automatically have access to WSIIS. The Local Agency can request access to WSIIS. The link above has information about how to request access. Added, # 5: Share the immunization schedule with caregivers of infants and children up to age 2 who aren't up to date. Staff may provide the <u>Parent</u> <u>Friendly Immunization Schedule</u> to caregivers. Added: The local agency has the option to screen all children for immunization status for ease and consistency. The local agency must assure staff use this option consistently for all families. A local agency policy isn't required. Information Removed (reworded and moved to policy): Some WIC staff find it easier to screen all children. This is a local agency option. 	Staff must ask the parent guardian or caretaker to provide the immunization record at certifications and mid-certification health assessments. Staff can use Washington State Immunization Information System if they have access to assess immunization status in lieu of the hard copy immunization record. Provide the Parent Friendly Immunization Schedule (or a link to the schedule) to parent guardians and caretakers of infants and children who aren't up-to-date on immunizations.
