The Department checks this by using the Course Verification Sequence (CVS) directory published by the Association of Behavior Analysis (ABAI). It appears that the directory doesn't always give the full number of hours that each class has for the specific subject(s). This is different for each college or university. The committee will discuss ways to make checking this information easier for staff, while also making it as easy for the college or university as possible, in order to make the process to issue an LABA license move as quickly as possible.
