Dear Mr. Long:

Enclosed is Replacement Authorization (RA) #083 issued to Fresenius Medical Care approving the replacement of FMC-North Pointe Dialysis Center to a new site within Spokane County planning area #2. At project completion, FMC-North Pointe Dialysis Center will have 24 approved stations as noted on the certificate and described in the application.

Replacement Authorization #083 is valid for two years. The project must begin during this time. If there is substantial and continuing progress, we may extend the authorization for one six month period. For an extension, you must submit an extension request at least 120 days before the expiration date. You cannot begin a project after the expiration date.

This decision may be appealed. The two appeal options are listed below.

Appeal Option 1:

You or any interested or affected person may request a public hearing to reconsider this decision. The request must state the specific reasons for reconsideration in accordance with Washington Administrative Code 246-310-560. A reconsideration request must be received within 28 calendar days from the date of the decision at one of the following addresses:

Appeal Option 2:

You or any affected person with standing may request an adjudicative proceeding to contest this decision within 28 calendar days from the date of this letter. Description of Approved Project

Fresenius Medical Care is approved to relocate FMC-North Pointe Dialysis Center to a new site in Spokane ESRD Planning Area #3, within Spokane County as allowed under WAC 246-310-289, provided that Fresenius Medical Care agrees to specific conditions. On November 9, 2015, Fresenius Medical Care agreed to the following conditions.
