1. DESCRIPTION OF SERVICES PROPOSED

Bristol Hospice proposes to open a location in (county) to provide Hospice Services to the surrounding community. Bristol Hospice was founded in 2006 and is headquartered in Salt Lake City, Utah. It has provided Hospice services to more than 65,000 patients and families, with services spanning across 26 locations in eight states. The focus of Bristol Hospice is to provide a family-centered approach in the delivery of hospice care throughout all the communities it serves. With above National average survey scores in patient preferences and managing pain and treating symptoms, Bristol Hospice programs are designed to promote quality and comprehensive services to patients and their families. Bristol Hospice prides itself in keeping a standard one-hour wait time for patient consults, and admissions within four hours of a referral being received.
