Total Food Dollars Redeemed Fresh Fruits and Vegetables Only – Fresh fruit and vegetable dollars are a subset of Total Food Dollars Redeemed during FFY2019. Neither include FMNP dollars.

Total Food Dollars Redeemed WIC Farmers Market Nutrition Program – Includes dollars spent at authorized farmers markets & farm stores, and doesn't include other WIC dollars. Revenue based on growers location. Redemption period is between June 1 to October 31, 2019.
