Activities in the Growing Area in 2019

The growing area was sampled a minimum of six times in accordance with National Shellfish Sanitation Program (NSSP) Systematic Random Sampling criteria. San Juan County Health Services continues to implement an enhance maintenance and operation program in the area. San Juan Island Conservation District received National Estuary Program grant funding to conduct water quality monitoring, and provided agriculture technical assistance and BMPs.

Analytical Results of Water Samples

Table 1 summarizes the results of the last 30 samples collected from the area. This summary shows that all stations pass the NSSP water quality standard.

Change in Actual Pollution Sources that Impact the Growing Area

We currently have no information indicating that the area has new sources of pollution.

Classification Status

- Well within the classification standards
- Meets standards, but some concerns
- Meets standards, but threatened with downgrade in classification
- Fails to meet current classification standards

Remarks and Recommendations

Table 1 shows that all Approved stations meet the NSSP water quality standards and the area is correctly classified.



The standard for approved shellfish growing waters is fecal coliform geometric mean not greater than 14 organisms/ 100 mL with an estimated 90th percentile not greater than 43 organisms/ 100 mL. The above table shows bacteriological results in relation to program standards.

MAP 1. Westcott Bay Growing Area


