

Once the appropriate authorities have been identified, hold a meeting with them to discuss the proposed site of the program and to obtain a list of all pertinent stakeholder groups in the area. Documentation of these meetings will be required.

• PowerPoint Presentation attached. General information provided about the opioid epidemic, MAT services available, methadone, suboxone/bup benefits and risks. One question raised about how organization defines success for clients and concern about clients replacing one high for another. Dr. Fischer explained resources available for clients including counseling, psychiatry, peer support, employment, case management services and developing treatment plans with the client to define success. Dr. Fischer also explained that many clients come to agency homeless and without employment and due to services are able to find home and find a job. County invited Dr. Fischer to provide additional presentation to sub-committee about opioid epidemic in Clark County and MAT services.

This letter is to inform the City of Vancouver as required under WAC 246-341 that Columbia River Mental Health Services (CRMHS) Opioid Treatment Program located on Fourth Plain Blvd. will be moving a few blocks to a larger location in response to the growing need to serve more clients needing this life saving service. The new location is located at 7105 NE 40th St. Vancouver, WA 98661. CRMHS has seen a dramatic influx of individuals seeking opioid treatment services over the past two years and is currently Clark County's largest outpatient treatment provider for opiate addition. Individuals receiving treatment at our facility not only receive Medication Assisted Treatment (MAT), but also behavioral health services including substance use disorder individual and group counseling, case management, peer support services, and support in housing and employment. Our services have proven to be transformative for homeless clients; moving individuals with substance use disorders from tents into recovery, housing, and employment.







- Synthetic opioid & schedule
 Il controlled substance
- Potency 100X that of morphine
- Easy to manufacture in illicit labs – China & Mexico
 - Sold as powder & counterfeit pills





Clark County Public Health issues warning over use of fentanyl

- International shipping disruptions shifted drug supply from heroin to fentanyl
- · Fentanyl now opioid of choice
- · Client report: \$3 / pill

Synthetic Drugs → Here to Stay



Heroin = Complicated Logistics

- · Farmland & workers
- Irrigation, pesticides, fertilizers
- Cultivation followed by processing in a facility
- Smuggle big bulky packages across international borders

Fentanyl at Your Fingertips

- International: A lab with commonly available chemicals
- Local: Laptop, internet connection, PO Box



- 1 kg of FYL powder = 250 kg heroin
- Easier to smuggle a thermos than a dishwasher

Clark County: Fentanyl Use & Treatment Observations

- Generic Suboxone®: more complicated to start, some patients report less effective than past experiencing stopping heroin or Rx opioid use
- · Methadone treatment still effective, patients at higher doses
- · Patients early in treatment observationally more unstable
 - · Milieu challenges
 - Anger
 - · Threats of violence
 - Actual violence

Medication Assisted Treatment (MAT) at The NorthStar Clinic

Addiction is a Chronic Disease of the Brain


- · Long term, progressive & relapsing disease of the brain
- · Marked by stages of progress and regression
- Relapse and related behaviors are a feature of the illness rather than an indication of failure of the treatment plan or patient-effort
- With treatment, success rates for recovery from SUD are similar to other chronic diseases like
 Type II Diabetes and congestive heart failure
- Disease model approaches equal better outcomes



NorthStar Treatment Services



How do MAT Medications Work?

- · Agonists Methadone and Buprenorphine
- Bind to opioid receptor slow on, slow off = no euphoria
- Reduces cravings
- Prevents withdrawal symptoms
- Blocks effect of illicit opioids
- Help the brain feel normal, to allow for the work of recovery






opioid-based MAT?

- Most effective treatments in OUD
 - 40-60% reduction in risk of death
 - · Heavily Studied
 - · Reduction in HCV / HIV infections, other IV drug use related infections
 - · Improvement in pregnancy outcomes
 - · Decrease in criminality
 - Improved retention in treatment services
 - NorthStar Experience
 - ~66% of Methadone patients are still in treatment after 90 days
 - ~33% for buprenorphine/naloxone
