2. RULES UPDATE

- 2.1. WAC 246-817-150 Licenses Persons licensed or qualified out-of-state who are faculty at school of dentistry Condition
 - Ms. Freeberg shares the CR 102 has been published and the rule hearing will occur at the January 19 business meeting.
- 2.2. Dental and Dental Hygiene Compact
 - Ms. Freeberg shares the dental compact has been authorized, however the Department
 of Health will not open the CR 101 until it has been enacted with seven states
 included.
- 2.3. WAC 246-817-905 Opioid prescribing exclusions. Commission will discuss amendments. Commission may vote
 - Ms. Freeberg shares WAC 246-817-905 was a requested rule amendment and reviews the new rule language with the Commission.
 - The rule language mirrors the Washington State Medical Commission's rule.
 - There is a motion to approve language presented for opioid prescribing exclusions.
 - The motion is moved and seconded.
 - A vote is taken and unanimously passes.
- **3. DENTAL THERAPY COMMITTEE** Committee meeting held on November 9, 2023 Dr. Bryan Swanson
 - Dr. Swanson shares CRDTS provided the committee with a presentation on their examinations.
 - There are no dental therapy examinations, but one can be developed utilizing portions of dental license and dental hygiene licenses examinations.
 - CRDTS shares the examination could be developed within 6 months after approval.
 - CDCA/WREB/CITA will be attending the December 12 committee meeting with their materials.
 - The Commission discusses interested parties' participation.
