

# Integrating Doxy PEP Into Prevention Navigation Programs: Guidance for Navigators & DIS

Gay, bisexual, and other men who have sex with men (GBMSM) and transgender people experience higher rates of STIs than other populations, and the disparities are even larger for GBMSM and trans people of color. As an effective new prevention tool for cisgender GBMSM and transgender women, doxycycline as STI PEP has the potential to lessen health disparities. However, lessons learned from the introduction of PrEP for HIV and Jynneos as the Mpox vaccine demonstrate that an effective introduction of doxycycline as STI PEP will require careful attention to health equity. **Proactively informing people rather than waiting for patients to request this new intervention can facilitate more equitable distribution.** 

Use this guidance document to develop strategies for implementing doxy PEP into your Prevention Navigation programs, including syndemic navigation and partner services provided by DIS.

### Criteria for Offering Doxycycline as STI PrEP

It is important to develop criteria for who you will be proactively offering support in accessing doxycylcline as PEP. Based on CDC guidance, focusing efforts on reaching gay, bisexual, and other men who have sex with men (GBMSM) and transgender people will have the most significant impact in reducing the rate of STIs in those populations. In Washington, disparities in rates of of chlamydia, gonorrhea, and syphilis exist among Black non-Hispanic and Hispanic/Latina/o/x relative to White non-Hispanic individuals. This means it is important to address these disparities in prioritizing doxy PEP access among GBMSM and trans people of color. In collaboration with your integrated testing programs, you can also prioritize those testing positive for spyhilis or a bacterial STI as high priority for doxy PEP education and outreach.

# **Reducing Restrictions Based On Eligbility Criteria**

Excessive restrictions may impact doxy PEP from reaching those who may benefit most from the intervention. Identify providers willing to prescribe doxy PEP in your local area, navigating provider availablity to access a doxycycline prescription, and coordinate with insurance companies to cover medical costs associated with doxy PEP, and address any additional barriers to accessing doxy PEP. ### **Proactively Inform Clients about Doxy PEP**

As a relatively new STI reduction intervention, some clients may be aware of doxy PEP and others may know very little. **Proactively inform people rather than waiting for patients to request this new intervention can facilitate more equitable distribution.** Supporting GBMSM and transgender people will have the most significant impact in reducing STI ratesparticularly those testing positive for spyhilis or a bacerial STI has high priority for doxy PEP. It is also important to address disparities by prioritizing doxy PEP access among GBMSM and transgender people of color

### **Engage Community**

It is important to developing partnerships and trust with other agencies in your region. Develop strategies for engaging community partners. Consider hosting listening sessions or community education opportunities for people to learn more about doxy PEP. Who is already doing doxy PEP work in your community? Who do you know is prescribing doxy PEP? Who could be the doxy PEP "champions" in your community? These can include both providers and community members. Get feedback on your implementation guidelines, community facing materials, or messaging about doxy PEP.
