Met ewe Environmental Health Disparities Map (Ewe Map Pwe Pekin Safei Non Environment Mi Ese Faniten)?

The [Washington Environmental Health Disparities \(Ewe Map Pwe Pekin Safei Non Environment Mi Ese Faniten, EHD\)](#) (in English) ei eu pisekin map mi fitikoko. Ewe map a alofengen ekkewa leeni lon pwan fonu ren unusen Washington State ngeni unusen pwe ra ekkewa omwusomwus me osukosuk ren ewe fakun pollusan.

Ewe EHD map a kan rafan Washington ekkewa tract ngenikemi pwe ra ekkewa omwusomwus me mirit ren ekkóch feiengaw lon pekin safei. Ekkewa rank ra nomw seni ewe ngeni engon me wiser anonganong pwe wattenon ewe ukukun. EHD map a kan rafan ra anonganong won sokofesenin aramas, nap seni ar repwe angei pwe ran. Ekkewa ran ra mut ngeni an pwe wor awewe lefilen ekkewa kinikin.

Ren ewe HD map, Sia wewe ngeni ekkewa tract mi chék chéufetál pwe iir “mwü,” inaanwo ika esap ina usun ekkewa mwicheich ra kan pwisin áweweei Ewe ukukun ekkewa tract a fiti ekkewa taropwe pwe epwe anonganong won chommongun aramas. Ewe ukukun chon aramas lon eu tract a 5,000 aramas, nge epwe tongeni sokko seni 2,000 ngeni 8,000 aramas.

Ika non 2021, epwe mwan echemani fan iten Legislature ren Department of Health (Ewe Sosefan nom Faniten) [minefoon me tumunu ewe EHD map](#) fan ewe [Healthy Environment for All \(HEAL\) Act\(Pin seni angangan manawinech chok ngeni pwan ach\)](#). Ewe HEAL Act Pin HEAL a emwen fisu ekkewa paten kinikinin state pwe repwe wor awewe ngeni ekkewa mwich aramas ren ekkoch angangen repwe fori mei epwe tongeni faniten ewe fonu ika fori feiengaw. Me nukun, ekkewa nenien angang mi mumuta a emwen pwe repwe fori ekkewa angangen apwungan non nenier. Ekkewa anapanapen angang a fis pwe epwe emweni ekkewa finata ren ekkewa nenien angang pwe epwe awesi ekkewa pwongo faniten pweoch me pweoch chok, me pwe epwe wor pwan kinikinin feiochun neni me feiengaw ren kinamwonos. The HEAL Act (Pin HEAL) a affata ewe EHD map pwe eu pisekin angang epwe tongeni aea ren anisi ekkewa emwen annukun ekkewa angang mi pwan mumuta. Kose mochen sinei:

- Ese wor eu pisekin angang mi unusoch fan iten, pwe epwe esinna ekkewa mwichen aramas fan ewe HEAL Act (Pin HEAL) annuk. Sia pesei ngeni ach sipwe aea ei pisekin angang mi ririfengen ren pwan ekkoch pisekin angang, pisekin angang, me pisekin angang nupwen, pwe epwe esinna ekkewa aramas mi kon osukosuk me ekkewa aramas rese tongeni feiengau.

- Sia esinna ren mwich HEAL Act (Pin HEAL) Eni esap ina usun ekkewe mwichen aramas ra awewei pwisin, ir ar esisinata. Ekkoch aramas ra sani sokkopaten kapas, nge lap seni “lap ngeni” or “apwangapwang” mwü. Ekkoch kapas mi murinno ra kapachelong “fengeni,” or “etiwa.” Sia aea ewe kapas “fokkun efeiengaw mwü” ren ei kapas, pwe ewe usun ‘lap ngeni mwü’ non HEAL a kanne me pwani pwapwa seni ‘fokkun efeiengaw mwü from the [Clean Energy Transformation Act \(Pin ngeni nefiin eneoche seni pwapwa fan iten aninis, CETA\)](#). Ikkei ekkewe kapas mi anonganong non osukosuk pwe sia kutta ach sipwe awesi ekkewe osukosuk. Ikkei esap ewe sipin ekkewe mwichen aramas, nge epwe chok pwe ewe mwákun ese pwung non ewe kokkót. Ewe usun kapas non osukosuk esap pwe epwe fimet ekkewe pwapwa non mwü. Sia sinei pwe ekkei kapas epwe tongeni wor ekkewe nomnomun an epwe osukosuk ngeni mwü fan iten ar kewe nepinis.
- Ei map esap chok usun ewe pisekin finata ren ewe among me kinikinin non angangen muun fan porous. Ese wor chok eu pisekin angang mi tongeni fusun ekkewe nepinis non mwü. Ewein kinikinin tumunu me finata meinisin fan mwü me ekkewe fefen omw iseipwe mochen. Ewe EHD map pwe enochu fiti pwe tongeni won ekkewe mwü me Tribal nations pwe repwe angaangen.


Ewe pwe Environmental Health Disparities Map (Ewe Map Pwe Pekin Safei Non Environment Mi Ese Faniten) acad?

Ewe Department of Health (Ewe Sosefan nom Faniten), fiti porausfengen me ewe Environmental Justice Council, esapw emweni pwe fiti apontok me apwung non EHD map. Me nukun, ewe EHD map emweni ra apwung me ngeni pwe enochu seni fiti seni iten 3 ringen, epwe apwung ngeni updates ren ewe map pwe emweni mwü aramas me Tribal nations, me emweni ngeni data me saiens.

Ewe EHD map epwe usen awewan mettoch a uoch efeiengawa pwe alollofengenni mwü aramas, ekkewe pwe irir en sasing ren pwe menis.




Ekkewe mwü mi kon osukosuk me ekkewe aramas rese tongeni feiengau

Ewe kapas “ekkewe mwü mi kon osukosuk” epwe chon ewe mwü ien ekkewe aramas rese tongeni feiengau ra aninnis fan iten ekkewe feiochun neni me ekkewe finata mi pwal won pekin safeis. “Ekkewe aramas rese tongeni feiengau” ekei ese mwirin pwe won ekkewe anonganong usun pwe repwe wor kinikinin osukosuk non meinisin pwe apwe kinikinin non feiengaw Ekei kapas ra fiti pwisin non Healthy Environment for All [nom Angangen Manawinech chok ngeni pwan ach] (HEAL me) [Climate Commitment Acts](#) (CCA).

Ekkoch annuk ra chok mei aninnisin ekkewe mwü fan a fen kapas, me kose mochen usuni ewe aninnis mi fitting annukun ewe angangen pwan kose chok fori.

The HEAL Act's aninnis non ‘ekkewe mwü mi kon osukosuk’ a wor, nge esapw chok seni, ewe Clean Energy Transformation Act (CETA) aninnis non “fokkun efeiengaw mwü.” fokkun efeiengaw mwü mei:

1. Finata ren ewe Department of Health (Ewe Sosefan nom Faniten) using a uoch efeiengawa aninnisin. Ach a settin tupwu tract mi wor ewe ran (overall) 9 me 10 non EHD map pwe ar fokkun efeiengaw.
2. Eu tupwu tract mi wor pwan kapas me chok kapas non ar repwe kapas ngeni pwe “Indian Country.” Indian Country a wewe ngeni [18 U.S.C Sec. 1151](#). [Ei fail Excel](#) (in English) ei a listi ekkewe eu tupwu tract ren Washington me pwan ei a chommong pwe repwe a kapung ekkewe fonu ren reserfashen, fonu mi chok angangen, me fonu Tribal mi esap inomw ren reserfashen. Ei minen a tongeni angang pwe epwe wor kopwe angei non ewe map EHD ren angangen ewe aterap ‘Tribal Boundaries’



Sia esapw ika usun kinikinin, ewe fiti non Washington State ese mefi fan Indian Country non epwe pwisin. Ewe mettoch ngeni usun non how ewe U.S. a pwan ekkewe ren kinikinin ese mefi fan Indian Country ese esewe mefi non kachito [here](#).

Ewe mefi ren repwe wor kinikinin ewe pwepwe ren Tribal lands, ewe Department of Ecology (ECY) ren ika. ECY mewor me fei ewe naninis. Ewe naninis a fen ewe mwü me kinisin epwe weires me mecher en non ran mwirin. Sia esapw a fen ika usun ewe mwü non ewe ran me a fen ika ewe kinisin pwukkun napanap pwan ekkewe forimw me nge a fen ika ewe aramas ekkewe ese fiti woromw me ewe ewe usun. Pwe epwe wor fen ika ewe mwü non ewe ran ika kinisin, sia ese pwan pwe repwe fori ngeni mwü. Kose mochen sinei meinisin ngeni wor ECY pwan pwe ekkei epwe manaman ewe mwochen non ewe ran [peisin meinisin pisekin angang](#) (in English).

Ewe HEAL Act me ewe CCA ra aninisekich ekkewe mwü mi kon osukosuk me ekkewe aramas rese tongeni feiengaw fan eu usun epwe konnukkun ekkei aninisekich fan CETA me pwan epwe pweiti. Ekkewe angang HEAL repwe kinisou ekkewe mwü non project me project ren anisi ewe aninisekich fan ewe [Environmental Justice Council](#) (Environmental Faniten Minen Epwe Fiti Tongen Mettoch) me ewe angangen chok me anisi minne kinisou non ewe HEAL Interagency Workgroup (IAWG) me ewe Tribal Interagency Workgroup.

Me pwan, kose mochen pwan aea ekkoch kapas non ekkewe data, pisekin angang, me ewe mochen sinei non ewe mwü ren a kapas ngeni am Ewe prokram. A chok me aninnis, non ekkewe fonu non fansoun ewe fonu, iwe ekkewe tupwu tract mi fiti, kose mochen aea ekkewe data non tupwu block ren aninnis ngeni ekkoch minnefis. Ekkewe eu tupwu eppet ese mi tipis, mi tongeni apasa me rekkof non ewe tupwu tract. Ikkeke mi me tipis seni ekkewe geographic level epwe tongeni anisi ewe pisekin aramas, ngeni seni tinikinetin eis, meinisin, me pweires. The U.S. Environmental Protection Agency's [Ewe U.S. Agenis fan Epin Epwe Fanaoch Angangan Manawinech] [EJScreen](#) (in English) Ewor chommongun pisekin angang non ewe eppet tettenin kinikin.



The [HEAL Act](#) ewe DOH ese minne chok ewe finata non ekkewe Tribal mi apasaen fansoun meinisin U.S. ren aninnisin me emonon ewe EHD map. Ika 2023, ewe DOH epwe wor ekkewe aninnis me ekkewe fefin round table non chok pwan kapas kapas non ewe fansoun meinisin pwan ika Ewer 2023. Nuun ewe fitiiti me kapas kapas,

ewe DOH a etiw ren tongeni ekkei pwan ewe minne me minnei mi kinapot ngeni ekkewe Tribal, esap epwe chok ewe wenechar non ewe kapas mi wor pwan.

Ngeni minnei, ami pwan wor aninnisin fan iten chok affataw ren ekkei ekkewe Tribal ren tongeni anisuk ngeni minnei mi kinapot kin ewe map, anisi ewe mefi me osukosuk kin ewe map, me ren tongeni osukosuk ekkewe minnei me minnecheran ekkewe Tribal. Ewe DOH ese minnei ach chonito non pwan apasa ekkewe nepatcha mefi non ewe fen meinisin, mi afiti me kapas mi chok ekkewe minnecher an Tribal me mwü. Ewe DOH pwan angangen pwan me ese chonito chok ekkei an Tribal lands kin ekkewe mwü mi minnecher non ewe fetan meinisin an ekkewe mwü mi kon osukosuk non [HEAL Act](#) and [Climate Commitment Act](#).
