The Department of Health (department) has completed the review of your request under Washington Administrative Code (WAC) 246-310-050 for exemption regarding the proposed ambulatory surgery center in Auburn, within King County. Below is the information considered and the facts relied upon by the Certificate of Need Program in reaching its conclusion regarding your project.

#### INFORMATION CONSIDERED

- Ambulatory Surgery Center (ASC) exemption application received April 20, 2015.
- Supplemental information received on June 18, 2015.
- Revised Code of Washington (RCW) 70.38
- Washington Administrative Code (WAC) 246-310
- Washington Secretary of State and Department of Revenue information obtained from the respective websites
- Department of Health external provider look-up
- Department of Health Integrated Licensing and Regulatory System (ILRS)
- Certificate of Need historical files for the November 4, 1998, exemption approval for Cascade Orthopaedics, PLLC to use the facility under a time share agreement with Ear, Nose, Throat, and Plastic Surgery Associates.
- Certificate of Need historical files for the January 14, 2000, expansion of the sublease agreement between Cascade Orthopaedics, PLLC and Ear, Nose, Throat, and Plastic Surgery Associates.

#### **FACTS CONSIDERED**

- On November 4, 1998, the Certificate of Need Program approved an exemption request for a time share arrangement between Cascade Orthopaedics, PLLC and Ear, Nose, Throat, and Plastic Surgery Associates.<sup>1</sup>
- On January 14, 2000, the Program approved expansion of the sub-lease agreement between Cascade Orthopaedics, PLLC and Ear, Nose, Throat, and Plastic Surgery Associates.
- On January 19, 2015, Cascade Surgery Center submitted its annual Ambulatory Surgical Facility License Application update. The Certificate of Need Program noted a change in the address for the surgery center. Subsequent correspondence between the Program and Cascade Surgery Center identified that there was no longer a time-share arrangement with Ear, Nose, Throat, and Plastic Surgery Associates.
- Further, the site for Cascade Surgery Center changed from 101-2<sup>nd</sup> Street Northeast in Auburn to 126 Auburn Avenue, #200, in Auburn.
- Currently, the practice of Cascade Surgery Associates, PLLC is located at 122 Third Street Northeast in Auburn [98002]; the surgery center known as Cascade Surgery Center is located at 126 Auburn Avenue, #200 in Auburn [98002].
- Cascade Surgery Associates, PLLC has been registered with the Secretary of State office as an active Washington State corporation since January 11, 1995. The corporation is also registered with the Department of Revenue.
- Currently, Cascade Surgery Associates, PLLC is made up of eight separate members, each with a separate professional service (PS) corporation. The members and associated PS are listed below.

- The proposed ASC would be operated under the corporation of Cascade Surgery Associates, PLLC.
- Procedures to be performed at the ASC are those typically associated with interventional orthopedic procedures.
- The proposed ASC would not be operated under a management agreement.

### **CONCLUSION**

Ambulatory surgery facilities (ASF), subject to CN review, are defined in WAC 246-310-010(5) to mean "any free-standing facility, including an ambulatory surgery center that operates primarily for the purpose of performing surgeries not requiring hospitalization. The term does not include a facility in the offices of private physicians or dentists, whether for individual or group practice if the facility is not extended to physicians or dentists outside the individual or group practice."

In November 1998 and again in January 2000, the Certificate of Need Program approved an exemption request for a time share arrangement between Cascade Orthopaedics, PLLC and Ear, Nose, Throat, and Plastic Surgery Associates. At that time, Cascade Orthopaedics, PLLC was not made up of different professional service corporations each owned by a different physician.

Since the structure of Cascade Surgery Associates, PLLC, is made up of different professional service corporations, was the surgery center no longer qualifies for the exemption. Accordingly, the ASC is subject to prior Certificate of Need review. Since it is already established and operating without a valid exemption, timely submission of a Certificate of Need application is necessary.

Enclosed is a copy of the Certificate of Need rules, (WAC 246-310), regulations (RCW 70.38), and a blank application form should you wish to pursue this project.

#### APPEAL OPTION
