Dear Mr. Lopardo:

The Department of Health has completed its review of your request for a six-month extension to the validity of Replacement Authorization (RA) #067. As you know RA #067 was issued on August 3, 2009, approving the replacement of Avamere Highlands Memory Care and Rehabilitation in Tacoma, within Pierce County, to a new site in DuPont, also within Pierce County. Enclosed is RA #067E approving an additional six months from August 3, 2011, to February 3, 2012.

The RA is not approval for any other local, federal, or state statutes, rules, or regulations. Such a project may also need Department of Health approval for a construction plan and facility licensing or certification, as well as other federal or local jurisdiction permits.

This decision may be appealed. The two appeal options are listed below.

## Appeal Option 1:

You or any interested or affected person may request a public hearing to reconsider this decision. The request must state the specific reasons for reconsideration in accordance with Washington Administrative Code 246-310-560. A reconsideration request must be received within 28 calendar days from the date of the decision at one of the following addresses:

#### **Description of Approved Project**

Highlands Rehab, LLC is the existing licensee of Avamere Highlands Memory Care and Rehabilitation located in Tacoma, within Pierce County. Avamere Highlands Properties, LLC (Realco) is the building owner of Avamere Highlands Memory Care and Rehabilitation. Currently Avamere Highlands Memory Care and Rehabilitation is licensed for 86 skilled nursing beds and has zero beds banked under the alternate use section of Revised Code of Washington 70.38.111(8) and Washington Administrative Code 246-310-395.

This Replacement Authorization approves the replacement of Avamere Highlands Memory Care and Rehabilitation at a new site in DuPont, within Pierce County. The name of the new facility is unknown as of the issuance of this Replacement Authorization. Avamere Highlands Properties, LLC (Realco) provided documentation demonstrating approval of the replacement of Avamere Highlands Memory Care and Rehabilitation from Tacoma to DuPont. At project completion, the maximum number of beds at the new facility will be 86.

This Extended Replacement Authorization is effective from <u>August 3, 2011</u>, through <u>February 3, 2012</u>, unless withdrawn, suspended, or revoked in accordance with applicable sections of the Certificate of Need law and regulations.
