# Activities in the Growing Area in 2024

The growing area was sampled six times in accordance with the National Shellfish Sanitation Program (NSSP) Systematic Random Sampling (SRS) criteria. Station 216 was only sampled five times due to foul weather. This sample will be made up in 2025.

A routine three-year shoreline evaluation was completed, and the Department sampled ten drainages/discharges, evaluated OSS, and completed a drogue study as part of a water quality study prompted by a failing Marine Station within the Prohibited area surrounding the Bay Center Marina. No new or changes in pollution sources were identified that impact the growing area.

There was a growing area classification change from Prohibited to Restricted, resulting in a 230-acre upgrade. Northern Oyster Company plans to harvest oysters from the Restricted area (parcels 79001000291 and 79001000234) and move them to an Approved area (parcel 79005000103) for a minimum of 61 days.

Marine stations 114, 119 and 129 were dropped from routine sampling due to nearby station redundancy and good water quality.

No additional activities have been documented in the growing area.

### **Analytical Results of Water Samples**

Table 1 summarizes results of the 30 most recent samples collected from the area. All stations in the Approved area meet NSSP water quality standards. Station 125 is categorized as Threatened with an estimated 90<sup>th</sup> percentile of 35.8 FC/100mL. Table 2 includes the last 30 individual sample results for Station 125.

### Change in Actual Pollution Sources that Impact the Growing Area

We currently have no information indicating the area has new sources of pollution.

### **Classification Status**

- Well within the classification standards
- Meets standards, but threatened with downgrade in classification
- Fails to meet current classification standards

#### **Remarks and Recommendations**

Table 1 shows that all stations meet the NSSP water quality standards for an Approved classification and the area is correctly classified.
