# **Agency Recommendation Summary**

The Department of Health (DOH) requests funding to research options, analyze costs and benefits, and develop a successful plan to migrate Department of Health IT infrastructure and systems to the cloud or state data center. Per RCW 43.105.375, agencies must complete migration from their separate data centers by June 30, 2019 or receive an approved waiver from the Office of Chief Information Officer.

# **Package Description**

This proposal supports agency compliance with RCW 43.105.375 in two phases. Research, analysis and planning in phase one will inform a funding request for implementation in phase two. Benefits expected include reduced cost and complexity in maintenance of separate agency data centers and the opportunity to maximize the investment made in the state data center. The debt service on the state data center, currently burdening the state general fund, will be reduced as agencies with multiple fund sources migrate equipment to that facility. Cost benefit analysis may reveal that commercial cloud hosting better aligns with business needs and this effort will explore those options.

If this proposal is not funded, the Department of Health will be unable to comply with the direction set by the Washington State Legislature in <u>RCW 43.105.375</u>. Funding for current IT operations is either insufficient or not allowable to support the additional staffing, personal services and capital investment required for data center migration.

The Office of the Chief Information Officer, in consultation with the Office of Financial Management, is responsible for supporting the business plan and migration schedule for all state agencies. The OCIO may grant a waiver upon request, but if progress toward compliance is not clearly demonstrated, approval of future IT projects and agency delegated authority may be in jeopardy.

#### **Detailed assumptions and calculations:**

The Department of Health has maintained an on premise data center since the agency's creation in 1989. The Tumwater data center includes high quality computing and storage infrastructure, a modern telephone system, and a secure statewide network that supports all agency locations and business needs. A <u>report</u> commissioned by the Office of the Chief Information Officer in 2012 stated that the Department's Tumwater data center was a quality asset built to sound technology standards and that equipment and infrastructure would require replacement when obsolete. Statutes and policies adopted more recently direct the migration from agency data centers and prohibit new investment in agency data centers without an approved OCIO waiver.

Migrating from the Tumwater data center to the state data center or the cloud will be a major project and will require thorough analysis, planning, and resources to be successful. Considerations and complexities include the computing environment, hardware components, network connectivity, service providers, applications, and databases which make up the Department's IT portfolio. A few of these 400+ systems are hosted at the state data center, many are hosted on premise, and a growing number are software/platform as a service hosted in the cloud. Some systems cannot tolerate any downtime, many are required to meet critical business needs, and protecting the security of the data entrusted to the Department cannot be compromised.

#### Cost components, assumptions, and estimating process/calculations

Cost components include:

- Staffing resources (Project Manager)
- Professional Services (External QA consulting, Independent Verification and Validation consulting, expertise in data center migration analysis and planning)

It is assumed that data center migration will result in decreased costs to the state as a whole while the cost of services for individual agencies may increase. The Department should begin realizing cost avoidance benefits in approximately seven to ten years, when current data center equipment is projected to become obsolete. Cost reductions for staffing or operational costs are not expected.
