# **Package Description**

The Public Health Supplemental Account was created for the Department of Health to receive gifts, bequests, devises, or funds, whose use is determined to further the purpose of maintaining and improving the health of Washington residents through the public health system. The Department is requesting additional appropriation from this fund for those purposes.

#### 1. Behavioral Risk Factor Surveillance System

Behavioral Risk Factor Surveillance System (BRFSS) provides data collection (survey) for state agencies and local health jurisdictions. The survey is primarily funded through DOH, with "state added" questions funded through a partnership between DOH and other agencies. Local health jurisdictions and community agencies routinely collaborate to fund questions.

When a community entity requests and funds an additional question for the survey, DOH receives and expends that revenue from Public Health Supplemental Account. DOH currently does not have enough appropriation to support a multi-year request for a question regarding firearm safety. The department is requesting additional appropriation to expend these donated funds from community entities.

#### 2. Stratis Health

The purpose of this grant is to integrate palliative care into rural community settings. This funding will be used to support demonstration of a telehealth case consultation and training service for seven sites. The funds will support the contracts with professionals who offer the clinical consultations and training, as well as a contractor to manage the coordination of the schedule, technical platform, technical support and HIPAA compliance certification. The funds will also support employee travel to coordination and planning meetings, and additional palliative care training programs delivered to multiple audiences in the rural community settings or online.

#### Rita and John Hillman Foundation (HSQA)

Rita and Alex Hillman funds will be used to continue the Telehealth Case Consultation pilot serving seven rural communities in the first cohort of the WA Rural Palliative Care Initiative (WRPCI). WRPCI is led the State Office of Rural Health at the Department and a public-private partnership with over 24 organizations advising or participating, including both UW and WSU. The project seeks to help rural communities provide effective services for people with serious illness and their families while focusing on quality of life, patient goals, and symptom management. The telehealth case consultation pilot uses a panel of palliative care experts to consult on de-identified cases presented by the cohort of communities while all seven clinical

teams listen in, using a HIPPAA compliant Zoom web based service contracted through Northwest Telehealth.
