Agency Recommendation Summary

The Department of Health (DOH) requests additional local spending authority to cover the costs of Washington state performing Newborn Screening testing for Idaho and Hawaii, which started April 2021 and additional authority to cover increased costs of premiums and prescriptions for eligible clients living with HIV/AIDS in Washington State.

Decision Package Description

Item1: Newborn Screening: The Department of Health (DOH) requests additional local spending authority to cover Washington state performing Newborn Screening testing for Idaho at \$116.40 charge per baby that is tested, and for Hawaii at \$66 charge per newborn screening starting April 2021. Approximately 22,000 births per year for Idaho and an estimated 16,844 births per year for Hawaii. Invoices will be sent to Hawaii and Idaho each month with the number of screens completed. Payment will be generally received the following month. Projected revenue is based on historical birth data from Hawaii and Idaho.

Item 2: The Department of Health is requesting additional authority of \$4 million per year from General Fund-Local to ensure adequate funding of the Insurance Benefit Manager and Pharmacy Benefit Manager contracts related to insurance benefits and HIV medication access for eligible clientele. This additional authority will cover increased costs of premiums and prescriptions for eligible clients living with HIV/AIDS in Washington State. For purposes of this decision package all cost is associated under object N.

How is your proposal impacting equity in the state?

The office of Infectious Disease is committed to reducing disparities and improving health equity and outcomes related to HIV. This additional authority will allow us to continue working towards these goals. It should be noted that in Washington the Hispanic/Latinx Community is disproportionately impacted by the HIV epidemic. While Hispanic/Latinx individuals comprise 13% of the total state population, they represent 21% of the new HIV cases. Similarly, Washington's Black Community represents 4% of the total population but 19% of new HIV diagnoses. These communities are not all getting the HIV medical care and other support services they need. Continued funding of this additional authority allows our Office and DOH to fund programs that are culturally and linguistically appropriate to reduce these disparities. With the additional spending authority we will be able to provide equitable services for newborn screening to Hawaii and Idaho families and providers.
